

# Village Board passes 2004 budget - no tax increase

It is never a pleasant experience getting a tax bill in the mail, but this June. like the last thirteen Junes. Village of Pomona residents will get a pleasant surprise when they open their tax bills. The 2004-2005 budget requires no tax increase. The board was able to hold down cost increases to a minimum, and balance them with revenue increases resulting from a slightly larger tax base, a restructuring of fees related to building and development in the village, and higher grant revenue which has funded all capital improvement projects for 2004. The Board unanimously adopted the budget on April 12th after a Public Hearing, thus meeting the deadline imposed by New York State law.

The same meeting saw the official village reorganization resolutions and appointments for the year 2004-5. There were no changes to village personnel or consultants proposed in the meeting, and the resolutions all passed unanimously. A complete listing of village personnel is posted on the village website.

#### Message from Mayor Herbert Marshall ...

I know April is best known for budding trees, spring rains, and golden daffodils. However in village government it is also the time of budgets and reorganization, and you should know about both. So here goes.

Budgets. The budget process under which all New York villages must function is very closely controlled through a series of very specific requirements mandated by State Village Law. Since our fiscal year begins on June 1<sup>st</sup>, we are required to begin the budget process by February 8<sup>th</sup>, hold a public hearing on our tentative budget before April 20th, and adopt our final budget no later than May 1st. In our village, the public hearing on our 2004-2005 Village Budget took place on April 12<sup>th</sup> as part of our scheduled Village Board meeting with the Final Budget being adopted at that very same meeting. What did it contain? For the 13<sup>th</sup> straight year .... NO TAX INCREASE. That's right, through careful management of our revenues and a fiscally responsible approach toward expenditures, we have once again been able to hold the line on taxes. Our Cultural Center and recreation programs will continue to flourish, our parks and streets will continue to be well maintained, our village services will remain constant, and your 2004 village tax bill will be exactly the same as last year. This year's budget also includes several key Village Hall enhancements, some interesting beautification projects, and the establishment of an Emergency Center to centralize communications and provide emergency services when hurricanes, snow storms, or other major problems disrupt life in our village. And in case I didn't mention it ... NO TAX INCREASE.

Now Reorganization. Each year, usually as part of the first Village Board meeting in April, most villages in New York perform an annual ritual called Reorganization. It is a time when village officials are appointed or reappointed, official newspapers and depositories are set, an annual meeting schedule is approved, and in our case, Village Board Oversight Areas are established. This year all official appointments remained constant and the following Individual Oversight Areas set.

Deputy Mayor Nick Sanderson: Office Operations and Technology, Grant Acquisition, and Public Relations.

Trustee Ian Banks: Buildings and Public Works, Village Maintenance, and Parks Management.

Trustee Alma Sanders Roman: Village Beautification, the Recreation and Ethics Committees, Cultural Center, and Environmental Concerns.

Trustee Alan Lamer: Planning and Zoning Boards, School Liaison Committee, and Legislative Review



On Earth Day 2004 (April 22<sup>nd</sup>), Dr. Constantine Gletsos, Village of Pomona resident, and dedicated village volunteer, was justly honored by Rockland County Executive, C. Scott Vanderhoef during a ceremony at Kennedy Dells Park in New City.

We know Constantine as the tireless organizer of volunteers, founder and Chairman of POCUS (Pomona Cleanup Squad) and organizer of the "Stream Team" which marked 526 storm drains along 15 miles of roads in the village with warnings about the dangers of illegal dumping and the importance of protecting the county's water supply.
