Mayor's corner ...

As I sit down to write for the Summer newsletter, I feel I should begin by providing an update on the various lawsuits facing the village. Most times when I sit down with groups of residents, the first question is about the status of our legal battles.

At the time of writing this, we are

still awaiting a decision on our motion to dismiss the Tartikov lawsuit against the village. We had oral arguments on our motion last May, and have yet to hear from the judge, although a decision is expected soon. The village won a long-standing legal battle last month, when a jury returned a unanimous verdict for the village in the lawsuit started a number of years ago by Summit at Pomona and its principal, Samuel Schecter. Summit had sued the village claiming that somehow we had impeded his development on the mountain and prevented him from building homes there. For years we have been vigorously defending the village, the costs of which have been covered by insurance. In spite of many attempts to settle the case by negotiation, it was not to be, and a two week long jury trial ended with the decision in favor of the village. The downzoning of Patrick Farm continues unabated, with plans to build nearly five hundred homes on the property being approved by the town of Ramapo. This has led to the village filing a lawsuit charging that the town improperly changed the zoning and the town's master plan without heeding objections from the village and the county planning department, all apparently for the benefit of a developer, and in detriment to the village. In addition to the village's action, two other lawsuits have been filed against the town by residents who live nearby. If any resident has any questions about these or any other matter, please contact me, either through village hall or directly, or by all means come to my monthly informal "coffee with mayor" - dates and times are always posted on the village website.

But enough about lawsuits. There are plenty of other things going on in the village. We are looking forward to the annual Lou Cohn Fish-In for children in the village, which will be held at Fairty Pond on June 27th, as well as the fourth annual Music Festival and Craft Fair which will held at village hall on July 11th. These summer happenings are always popular, and 1 want to sincerely thank all of the volunteers who's efforts make these events run so smoothly and make it possible for the village to host them at minimum cost to the village.

Many of you will have noticed the construction of a sign at Village Hall. This is an Eagle Scout project by local resident Justin Gedeon, who has designed, fund-raised, purchased materials and constructed this project for the village. Well done, Justin, you have done a great job, and we are all looking forward to a formal dedication and recognition of the project.

I cannot close this without some reference to the budget recently passed by the village board, and the taxes that have been levied as a result. The budget passed with a 1.6% tax increase, kept low by fiscal responsibility and conservatism. Some residents, however, have seen an increase in their village taxes greater than the 1.6% increase in total levy. This is the result of having ceased to be our own assessing unit, instead using the two towns' assessments. Some residents will have seen increased taxes, and other residents will have seen decreased taxes as the assessments in some cases were different from last year's village assessment. Next year, these changes will not be apparent.

Please keep your street clean, and you are also encouraged to come to village clean up events (POCUS - third Sunday of each month, either at 10am or at 2pm, meeting at Village Hall).
