Some notes from the Mayor ...

I want to use this month's Mayor's notes to let the village residents know more about the lawsuits that the village is involved with.

The question on most residents' minds concerns the current status of the Tartikov lawsuit. As you are no doubt aware, the village was

sued in Federal Court by the Congregation Rabbinical College of Tartikov, et al., in which they have alleged that the village has violated their civil rights as protected by the US and New York State Constitutions, the Religious Land Use and Institutionalized Persons Act (RLUIPA) and the Fair Housing Act. They allege that the village's zoning code prevents them from using the property they own for a Rabbinical College with housing for the students and their families. The village intends to vigorously defend itself from these allegations, and to that end have assembled a formidable legal team to represent the village. We have retained the law firm of Robinson & Cole to be our lead litigators in this action, and have also retained Prof. Marci Hamilton to be of special counsel. The lawsuit is in the early stages and we will be responding to the lawsuit as directed by the court. I will periodically use this forum to keep you informed as to the progress of the case.

Another case that the village is involved with is the lawsuit brought by the villages of Chestnut Ridge, Montebello,

Pomona and Wesley Hills against the Town of Ramapo. This action was brought to challenge the Town's adoption of the Adult Student Housing local law and the project on Grandview Avenue (former Nike base).

The State Supreme Court dismissed the action by the villages on the grounds that the villages did not have standing to bring the lawsuit. The villages appealed, and recently the Appellate Division, in a unanimous decision, found that the villages do have standing on the issues of SEQRA, the Town's failure to adequately address the environmental issues, and on certain procedural issues. It also found that Wesley Hills has standing to challenge the Grandview Avenue project. This means that the lawsuit is reinstated, and can go forward to conclusion.

Our attorneys in this case are the law firm of Zarin and Steinmetz, and they have been instructed to request the court to reinstate the Temporary Restraining Order which was lifted when the action was dismissed. The TRO, if granted, will stop all construction at the Nike base, and will keep the other three adult student housing sites from applying for and getting their multi-family housing developments, one of which would be slated for the Patrick Farm, immediately adjacent to the village.

FYI

- The Sunday evening Yoga class will start again on Sunday, Sept. 16th at 5:30 p.m. If you wish to participate, the class is free to village residents (\$10 per class for non-residents). Just bring a mat or towel and wear comfortable clothing. All levels are welcome.
- STAR (New York State's School Tax Relief Program that includes a school property tax rebate program and a partial property tax
 exemption from school taxes)

Rebate checks will be available in early fall. However, this year, the NYS Dept. Of Taxation and Finance informs New Yorkers that no application is required if you are presently receiving Enhanced* STAR. Check will be issued automatically. If you are receiving basic STAR benefits, an application is required. The application will be sent to property owners on the files that the agency receives from the State Office of Real Property Services. Applications will be mailed out September 17, 2007. The NYS Tax Dept. is encouraging property owners to apply online, but you can also complete the paper application. Apply for your rebate by going to the Tax Dept's website at www.nystax.gov. You can call the Tax Dept. at 1-877-678-2769.

- *Enhanced Star is available for the primary residences of senior citizens (65 and older) with yearly household incomes not exceeding the statewide standard. Call your Town tax accessor for more info.
- It's Tick Season Tick Removal Advice (this is great advice that we would like to pass on). Deer and deer ticks are prevalent in our area. This piece of advice came to our attention by a school nurse. It is a great way to remove a tick; ticks are sometimes difficult to get to with tweezers; between toes, in the middle of a head full of dark hair, etc. Apply a glob of liquid soap to a cotton ball. Cover the tick with the soap-soaked cotton ball and let it stay on the repulsive insect for 15 20 seconds, after which the tick will come out on its own and be stuck to the cotton ball when you lift it away. This technique has worked every single time, according to the nurse who passed along the info.
